Position: Maintenance Test Pilot
Position Description: Performs duty as a full-time-support Maintenance Test Pilot and Maintenance Officer for Det 2, G Co, 2-104th General Support Aviation Battalion and the DCARNG Army Aviation Support Facility (AASF). Performs duty as a Maintenance Test Pilot and Pilot-in-Command. Routinely coordinates with the Facility Commander, AASF Maintenance Pilot, Operations Officer and Production Control Officer on requirements to ensure aircraft are capable of accomplishing its operational missions. Provides technical advice and recommendations on associated maintenance functions and contributes to continually updating the Maintenance Standard Operating Procedures. Performs duty as an Additional Flight Training Period Supervisor for traditional aircrews. Serves as an Air Mission Briefer for aircrews and conducts additional tasks as assigned. Performs duties in challenging weather and terrain along with conducting duties at various periods to include nights, weekends and holidays.
Qualifications: <ol style="list-style-type: none">1. Must be able to retain a SECRET security clearance.2. Must meet physical fitness standards in IAW AR 600-9.3. Must continue to meet requirements of AR 135-18 and NGR 600-5.4. All applicants are subject to a state background check prior to the start of the AGR tour.5. Copy of DA Form 759 and 71226. Be a qualified UH-60 Maintenance Test Pilot8. Hold a current 2992 Flight Medical barring any temporary medical issues.9. Demonstrate expertise and experience in aircraft maintenance checks required of a maintenance test pilot.
Eligibility Requirements: <ol style="list-style-type: none">1. Applicants who have voluntarily separated from the AGR Program are not eligible to re-enter for one year from date separations.2. Must meet the military and civilian education requirements that has not been waived by the approval authority.3. Soldiers must be able to receive a favorable suitability screening during the accessions process as outlined in applicable service component regulations.4. Prior to entry on AD or FTNGD in the AGR Program, must be medically certified as drug free, be tested negative for Human Immunodeficiency Virus (HIV), per AR 40-501 and AR 600-110.5. Must meet all eligibility requirements in accordance with AR 600-9, AR 40-501, AR 135-18, and NGR 600-5.6. IAW AR 135-18, Table 2-3, Rule H, if the applicant does not meet the entry requirements defined in Table 2-1 and Table 2-2, the disqualification must be waived by the proper authority (if applicable).
