Brief Description of Duties:

Serves as the Commander, DCARNG Officer Candidate School (OCS). Responsible for recruiting, planning, conduct, and assessment of candidate training during OCS Pre-phase and Phase 2. Establishes and maintains the OCS environment in accordance with the OCS Platoon Trainer Guide, the Program of Instruction, Course Management Plan (CMP) as well as provide command and control, administrative support, and command supervision of established policies and standards pertaining to the performance, care, conduct, appearance, and safety of all officer candidates, platoon trainers and instructors assigned to OCS. Supervise the conduct of candidate leadership evaluations IAW the OCS Platoon Trainer Guide and the CMP. Resolve OCS CMP and courseware conflicts with the OCS TASS battalion.

Special Qualifications: N/A

Eligibility Requirements:

1. Minimum rank: CPT (CCC Complete)
2. Maximum rank: MAJ
3. The Soldier must have a current passing APFT/ACFT.
4. The Soldier must be assigned to the DCARNG, be in good standing, and must not be under a suspension of favorable actions per AR 600-8-2, Suspension of Favorable Personnel Actions (Flag), 5 April 2021.
5. If you are on Title 10 orders, you must revert to Title 32 Status to take command. This process must be coordinated through the CoS, LCC, and the TAG.
6. The Soldier must meet the Army medical retention standards in accordance with AR 40-501, Chapter 3, and as outlined below. The MEDPROS Individual Medical Readiness Report (IMR) must be current and reflect:
 - A current (12 mo.) Physical Health Assessment (PHA) and no Individual Medical Readiness (IMR) deficiencies.
 - A current HIV test. All Soldiers must have a current negative HIV-1 test within 2 years of the projected report date.
7. The Soldier must be fit for retention in his/her Primary MOS.
