- 2. Eligibility and Service Obligation.
- a. I understand I must have at least two (2) years of service remaining from the last day of the course funded by DC TA.
- b. I understand that failure to complete this service obligation will result in recoupment of DCTA funds.
- 3. Application Submission.
- a. I understand my complete application must be submitted at least 30 days prior to the course start date.
  - (1) Failure to meet this deadline may result in rejection of my application.
- b. I understand my application packet must include all required documents as outlined in the DC TA policy:
  - (1) Completed DC TA Application Form.
  - c. Signed Statement of Understanding (this document).
  - d. Memorandum of Good Standing.
  - e. Itemized Cost Verification from my school.
  - f. Official Degree Plan.
  - g. Approved Federal TA summary or proof of ineligibility.

- 4. School Requirements.
- a. I understand that my school must be registered with the DC Government Vendor Services Portal for invoicing and payment.
  - (1) If my school is not registered, I am not guaranteed funding.
- b. I understand that if my school does not have a current DoD MOU listed on www.dodmou.com, my maximum annual benefit will be reduced from \$20,500 to \$16,000.
- 5. Changes, Grades, and Payment Deadlines.
- a. I understand I must notify the Education Support Officer and/or DC TA Program Manager within five (5) business days of any change to my enrollment, including adding, dropping, or changing courses.
- (1) Failure to report changes may result in non-payment or recoupment of funds.
  - (2) I am responsible for any additional fees resulting from course adjustments.
- b. I understand I must submit my final grades within 30 days after course completion.
  - (1) Failure to do so may result in non-payment or recoupment of funds.
- c. I understand I am responsible for ensuring my school submits all required payment documents to the DC Government within 30 days after the course end date.
  - (1) Failure to meet this deadline will result in non-payment.
- 6. Program Limitations and Penalties.
- a. I understand that DC TA is not guaranteed and is awarded on a first-come, first-served basis based on available funding each fiscal year.
- b. I understand that misuse of funds, submission of false documents, or failure to comply with DC TA requirements may result in:
  - (1) Suspension from the DC TA program.
  - (2) Recoupment of funds.
